I. Call to Order

III. Adopt Agenda

Hannah motions to adopt the agenda. Matt seconds the motion. All in favor; the motion passes.

IV. Public Comment

a. Glenn Owings, 4-H's proposal/request for 2020 Fair Glenn and Amy Wilson give an overview of the tentative 4-H schedule. He requests that 4-H large animals be allowed to stay overnight for their health and wellbeing; small animals will not stay overnight. The schedule is based on limiting the number of individuals in the barn and on the Fairgrounds to comply with current health orders. Glenn speaks to logistics of having the 4-H livestock sale in the Rodeo Arena and are requesting that the sale be moved to the Rodeo Arena this year.

b. Other

Brad Luenz believes 4-H is important and thinks the Fair Board should use JH Rodeo for the Fair Rodeo.

Jeff Lutz also supports 4-H and thinks the Fair Board should allow JH Rodeo to operate on their normal nights during Fair.

The Board discusses the logistics for 4-H campers regarding physical distancing, cleanliness, and increased hygiene.

ACTION ITEMS

V. New Business

- a. 4-H Livestock, Overnight in the Heritage Arena Deb motions to approve this as written. Tere seconds the motion. The Board discusses security options, the days the campers will need to camp, and that the barn will not be open to the public. No further discussion. All in favor; the motion passes.
- b. 4-H Livestock Families, Overnight Camping from Deb motions to allow 4-H livestock families overnight camping from Wednesday through Sunday of Fair Week as per the proposed schedule. Steve seconds the motion. The Board discusses how camping spots will be marked to comply with physical distancing and current health orders. 4-H will decide which campers will receive electrical hookups and the Fair Office will have to charge these campers for electricity. No further discussion. All in favor; the motion passes.
- c. Relocate 4-H Livestock Sale to Rodeo Arena Rachel gives an overview of what the livestock sale will require to be held in the Rodeo Arena. The layout for the sale is dependent on the reach of internet so that 4-H can run their sale software. Amy motions to relocate the livestock sale to the Rodeo Arena. Steve seconds the motion. The Board clarifies that setup and takedown for the sale is covered in the construction contract. No further discussion. All in favor, the motion passes.

d. Turn N Burn

Rachel provides an overview of the run of show for Turn 'n' Burn and explains that it was cut from Fair programming along with all other third-party programming. The Fair Board is not capable of providing added money for Turn 'n' Burn this year due to budget cuts. Amy Hindman speaks on behalf of

TBRA, requesting that Turn 'n' Burn be added back into Fair programming. The Board discusses how many people will participate in and how many spectators are anticipated. TBRA will need to work with Environmental Health to submit a health plan that meets current health orders. Deb motions that we consider Turn 'n' Burn after they go and speak with Sara to come up with an idea for correct protocol for COVID 19. Tere seconds the motion. The Board clarifies that it is feasible to add Turn 'n' Burn back into the schedule if approved by Environmental Health. The Board will need to review and approve TBRA's Tun 'n' Burn plan at the July 13 meeting. No further discussion. All in favor; the motion passes.

e. Cleaning Contract

The Board discusses the changes that were made to the updated cleaning scope of work. Hannah motions to recommend approval by the Board of County Commissioners for the updated TM Commercial Cleaning contract bid. Gary seconds the motion. No further discussion. All in favor; the motion passes.

f. Construction Contract

The Board discusses the changes that were made to the updated construction scope of work. Gary motions to recommend approval by the Board of County Commissioners for the updated commercial contract bid. Tere seconds the motion. The Board discusses rolling the ground in the Heritage Arena versus not rolling the ground. All in favor; the motion passes.
