OFFICIAL SUMMARY PROCEEDINGS OF THE BOARD OF COUNTY COMMISSIONERS, TETON COUNTY, WYOMING

The Teton County Board of Commissioners met virtually in regular meeting on **August 30, 2021** in the Commissioners Chambers located at 200 S. Willow in Jackson. The meeting was called to order at 9:00 a.m.

Commission present: Natalia Macker, Chairwoman, Luther Propst, Vice-Chairman, Mark Barron, Mark Newcomb, and Greg Epstein were present via Zoom.

ADOPT AGENDA

A motion was made by Commissioner Barron and seconded by Commissioner Epstein to adopt the agenda as presented. Chairwoman Macker called for a vote. The vote showed all in favor and the motion carried.

MOMENT OF SILENCE FOR FALLEN MARINE - the Chairwoman called for a moment of silence to honor Rylee McCollum, a Jackson Hole High School graduate and United States Marine who was killed in Kabul, Afghanistan on August 26, 2021.

The initial contract term was for three months, with the option to renew in one month increments for an additional three months if both parties so agree.
