Board of Commissioners Action Summary

This section summarizes major actions taken by the Teton County Board of Commissioners. The Agenda Center on the County's website contains meeting minutes for a more detailed record of discussions and decisions.

- At the regular meeting on May 1, 2018, the Board of Commissioners approved a resolution proclaiming May 2018 as Mental Health Awareness Month in Teton County. - At the regular meeting on May 1, 2018, the Board of Commissioners approved a resolution proclaiming May 7th through May 12th as Spring Clean-Up Week. - June 4, 2018 - Housing Rules & Regulations, Joint Town/County Meeting, 3rd Reading/Adoption, 3:00pm
- June 6, 2018 - Housing Requirements, Joint Town/County Meeting, 1st Reading, 6:00pm
